## ORDER:

- 1. The "Annamacharya College of Pharmacy, New Boyanapalli, Rajampet, Kadapa Dist." was given Temporary affiliation for running Degree courses during the academic year 2013-14 vide Procs.(1) read above.
- 2. The AICTE, New Delhi and Government of A.P have accorded extension of approval to the above college for the academic year 2014-15 vide ref (2) and (3) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for the grant of **Permanent Affiliation** from the academic year 2014-15 vide Procs. (4) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (5) read above. The Standing Committee for Affiliation has verified the Fact Finding Committee reports and other documents pertaining to the college and made recommendations for **Permanent Affiliation** from the academic year 2014-15.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report.

Deficiencies from previous inspections which are not complied

- 1. No physical separation of the boundary between Annamacharya CP & AITS, Rajampet.
- 2. 150 more computers are to be procured
- 3. Teacher to student ratio is to be maintained at 1:15
- 4. Senior faculty should be appointed for M.Pharm. courses at least one to each specialization
- 5. Qualified librarian is to be appointed. Further, library maintenance software is to be procured Deficiencies
- 1. No fax facility
- 2. Digital library should be established
- 3. Atleast 50% of faculty appointments should be ratified by the University

- 4. e-class room is to be provided
- 5. CC cameras are to be installed in the PG class rooms
- 6. GC is to be procured
- 7. English communication skills lab should be within the campus
- 3. Under the circumstances as stated above, the Vice-Chancellor is pleased to Grant Permanent Affiliation to "Annamacharya College of Pharmacy, New Boyanapalli, Rajampet, Kadapa Dist" sponsored by "Annamacharya Educational Trust, 2-2-25/P/7/1, DD Colony, Bagh Amberpet, Hyderabad" to offer Degree Course in the following disciplines with the intake shown against each for a period of <u>3 (Three)</u> years from the Academic Year 2014-2015 as detailed below:

However, the college is instructed to rectify the above deficiencies and submit a compliance report before <u>02-03-2015</u>, failing which the Permanent Affiliation will be withdrawn.

The Permanent/Temporary affiliation shall be subject to the following conditions:

- 1. The management shall follow the norms of AICTE and the rules of the affiliation of JNT University Anantapur in all aspects.
- 2. The management shall follow the Academic Regulations and examination schedule of JNT University Anantapur.
- 3. Anti-ragging measures to be taken strictly in accordance with UGC regulations on curbing the menance of ragging in Higher Educational Institutions, 2009 (F.1-16/2007 (CPP-II))
- 4. Regular meetings of College Academic Committee and Governing Body shall be conducted.
