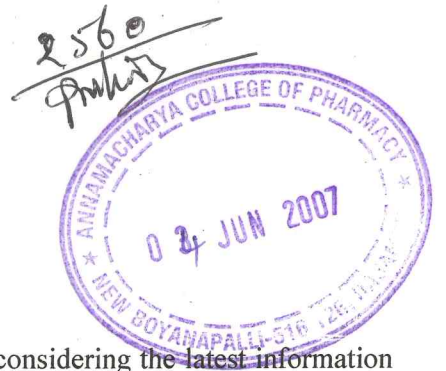

With reference to the subject cited above, I am directed to inform that considering the latest information on record, 78th Central Council of the PCI in its meeting held on 7th & 8th April, 2007 has decided as under -

"(1) In pursuance of the provisions of sub-section (1) of section 12 of the Pharmacy Act, 1948 (8 of 1948), the Pharmacy Council of India declares the **Degree** course in Pharmacy conducted by institution mentioned below to be an approved course of study for the purpose of admission to an approved examination for **Degree** in Pharmacy in respect of number of students and academic session as specified here under -



Sub.: New SIF's for Institutions conducting Diploma course in Pharmacy, Degree course in Pharmacy and both Diploma & Degree course in Pharmacy.

Sir/Madam

With reference to the subject cited above, it is informed that Council has revised the SIF's as under -

- 1) SIF for institutions conducting D.Pharm course. (SIF-A)
- 2) SIF for institutions conducting B.Pharm course. (SIF-B)
- 3) SIF for institutions conducting both D.Pharm & B.Pharm courses simultaneously. (SIF-C)

The revised SIFs have been launched on the PCI's website "www.pci.nic.in" and the same shall be implemented from 2007-2008 academic session. All the institutions seeking extension of approval are now required to submit the information in the revised SIFs only.

In this connection, it is again clarified that last date/cut-off date for submission of Standard Inspection Form (SIF) to PCI for consideration of extension of approval of Diploma/Degree course in Pharmacy is 30th September i.e. 9 months in advance of expiry of approval.

For Example


If the D.Pharm/B.Pharm course is approved upto	SIF duly filled in, in triplicate shall reach PCI's office on or before
2007-2008 academic session	30.9.2007
2008-2009 academic session	30.9.2008
2009-2010 academic session	30.9.2009
2010-2011 academic session and so on	30.9.2010

Please note that :-

- i) it is the responsibility of the institution to download the revised applicable SIF proforma (diploma, degree or both diploma & degree) from the Council's website and submit the same duly filled in within the due date as per above schedule. No separate SIF will be sent by the PCI.
- ii) institutions running both D.Pharm & B.Pharm course simultaneously shall submit SIF-C only. They need not submit separate SIF for diploma (SIF-A) & degree (SIF-B).
- iii) old SIF if submitted will be rejected & no correspondence on this issue will be done by PCI.
- iv) SIF received after the due date will not be entertained by the Council and the consequences thereof shall rest on the institution.

This is for necessary action and compliance.
