#### **C. Exchange of Faculty, Scientists and Staff**

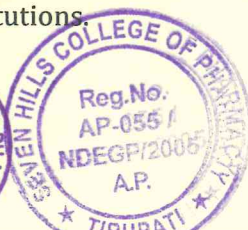
#### **E. Joint Conferences, workshops and short-term courses**

#### **G. Co-ordination**

Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee, consisting of (a) **Principal Annamacharya College of Pharmacy (Autonomous), Annamayya**, or his nominee, (b) Chairperson/Dean/Director/Principal, **Seven Hills College of Pharmacy (Autonomous), Tirupati**, or his/her nominee, (c) Programme coordinator from the side of **Annamacharya College of Pharmacy (Autonomous), Annamayya**, and (d) Programme Coordinator from the side of **Seven Hills College of Pharmacy (Autonomous), Tirupati** will periodically review and identify ways to strengthen cooperation between the two institutions.

#### **H. Tenure and Termination**

This MoU will take effect from the date it is signed by representatives of the two institutions. It will remain valid for **five years**, and may be continued thereafter after suitable review and agreement. Either institution may terminate the MoU by giving written notice to the other institution six months in advance. Once terminated, neither **Annamacharya College of Pharmacy (Autonomous), Annamayya** and **Seven Hills College of Pharmacy (Autonomous), Tirupati** will be responsible for any losses, financial or otherwise, which the other institutions may suffer.


#### **I. Arbitration Clause**

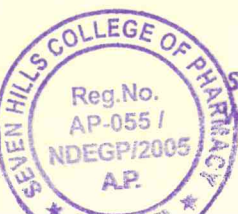
